#### **Current Research**

Stories Theology Lives By: A Narrative and Phronetic Theology of Liberation – A interdisciplinary DPhil thesis, which integrates the sociological thought and analysis of Pierre Bourdieu rooted in the continental philosophical tradition, the theological insights of the 'Yale School' of narrative theology and Paul Ricoeur, and research from cognitive science into narrative. In true continental form, it supplies a critical and constructive solution to symbolic violence in the theological academy against narrative forms of theology without resorting to symbolic violence, both through a dialectic and phronetic epistemology of love and through narrating embodied solidarity in love that subverts via grace the existential source of symbolic violence.

The monograph-length argument unfolds by synthesising Bourdieusien sociological analysis and applying it to the theological academy through a case study of narrative theology to explore why and how narrative theology has failed to be embraced by academic theology despite the growing body of cognitive scientific literature that suggests it would be especially suited to theology. From this exploration it constructs a way of doing theology with narrativization at the centre and considering how institutional structures might be optimised to allow for narrative to be embraced.

The hope is that by allowing for a more transcultural form of theologising through narrativization, that those formerly marginalised from having their legitimate theological insights recognised might now find theology an act and field of intellectual liberation. It, therefore, aims to expand the range of thought and style within theology vis-à-vis continental philosophy. Thus, this thesis has implications for the humanities as whole, perhaps offering to extend liberation beyond the field of theology to the broader structure of the academy.

Sept 2008 to Dec 2010

*Sophie's Apocalypse* – A theological and philosophical exploration of the nature of the effect of death on the perception of value, social connection, technology, and time by human beings through narrative. Set 150-300 years in the future, a young woman receives an ecstatic vision of the world post-resurrection which transforms her entire perception of the nature of human civilisation, and the paradox of an eternal life in hope. While many narrative theologians advocate for narrative as a theological form, few have actually written intentionally theological narratives. This novel will serve as an example of narrative theology and thereby fulfil my argument in practice as well as theory. It will also extend my thesis' argument about the nature of symbolic violence to view it as a corollary of death and time as a form of capital, while also returning to enflesh a life legitimised by grace and expressing solidarity in love through both its epistemology and phronesis.

*Break Free: How to Win at Life when the Game is Rigged* – A popular-level book that draws upon the theological engagement with Bourdieusien analysis in my DPhil thesis, adapting it for the general public but also applying its insights to practical effect to help people to increase both their sense and practice of agency and to perceive the value they possess apart from their place in various types of social and cultural stratification.

Saving Predestination: Divine and Human Agency, the Nature and Narrative Logic of Salvation, and Cognitive Science – Does the doctrine of predestination need saving? What would it mean for it to be saved? Often predestination has been considered an esoteric consideration, or worse, a doctrine that presents a real ethical, existential, or philosophical challenge within the Christian tradition. It carries both profound philosophical and pastoral questions. Nevertheless, raising the theme of predestination is not known for eliciting the most positive responses. In this sense predestination needs saving from both the esoteric inclinations of its history of engagement and from the ethical, existential, and philosophical questions it raises. Yet, saving predestination is a double entendre. For this project also addresses predestination's relationship to salvation, to the questions of who gains a saving predestination, how they do so, and why. The project, Saving Predestination, will construct a contemporary Christian doctrine of predestination in which the narrative and affect enact the core logic of predestination in which the Triune God saves those whom He chooses in love and to love as both an expression of and invitation into His own agency in time and eternity for His glory. Saving Predestination will be rigorously Trinitarian as it builds out its constructive proposal over the course of a monograph consisting of six chapters of relatively similar length (about 20,000 words).

*How to Built Trust into AI and Big Data* - A series of articles aimed at the general public and published online with the European Academy on Religion and Society has explored how to incorporate ethics into the structure of Artificial Intelligence (AI), both as a design feature and as a set of relations cohering between AI and its use and role within larger human society. This series draws from ethical frameworks rooted broadly within virtue ethics and aims at collective flourishing through sharing the power that AI offers to the human species across the human species rather than allowing the powers and opportunities of these technologies to become rarified and concentrated only in the hands of a select few, such as technology firms and governments.
